 Claiming/Fiscal Update Claiming Status – We are wrapping up March regular monthly claims. Deferred regular claims are current and are being completed 2-3 weeks of receiving the invoices. Claims Correction Spreadsheet (CCS) – Current and completed within 2-3 weeks of when we receive the actual invoice.  Order Connect NX – There is a toolkit to have an edge add on to open the current version of Order Connect. Order Connect NX is not available yet but it does have the ability to be used in different browsers. There will be more information on this. 			
 CareConnect Inbox – There is still some issues with CareConnect Inbox. The issue right now is that it is not System Code secure so we are still working with Netsmart to get this fixed. 			
 Perceptive Update – There is an update to Perceptive. There were some issues that some people were having with Document Capture Perceptive. There is a new Perceptive Web Scan Install that was updated on 4/18/22. If you are having issues with scanning, you may want to have your IT make sure you have the most recent Web Scan installed which is on our website.

 Is the expected Go-LIVE for everyone 6/6/22? – Yes, we will be sending the URL the Friday before, which is June 3rd. We will be sending it to all the Authorized Approver and everyone who is on our distribution list. We are going to leave the current version of Avatar LIVE for a short time in case there are any major issues but after a month or 2 we will be removing this URL. All staff will then be expected to be using the new Avatar NX version. Is there any new report viewer or software that needs to be installed? – There is only downloads for Order Connect, the Perceptive Scan tool and for the signature pad. Will the functionality work the same with uploading service for providers with their own EHR? – Yes, all of the features will remain the same. Will the favorite forms from the old Avatar still be there on NX? – Yes If we still use the old Avatar for a few days, it will not hurt anything correct? – That is correct. The two versions have 2 different URL but both go to the same back end table. Question about being unable to view To-Do box on NX – We didn't have this issue with the Go LIVE with early adopters. We encourage to wait until Go LIVE and if the issue persists, to contact support.
