	Reminder – Sacramento county has not submitted a CSI production file to the State since Sacramento county went live in May 2009  Q. Do we have to go back to May 2009 and clean up CSI data?  A. Yes. Please utilize the Missing CSI by Program Report. After running the report you will see what screen needs to be corrected.	
	To date we have received 22 lists out of 200+ agencies for missing living arrangements at time of admission. Please submit data as soon as possible. The CSI Error Report shows the missing living arrangements. If you are having difficulty please let your Contract Monitor know the circumstances.

	Requirements sessions are complete and the design of the CWS module is just about complete. There is a Design Review session scheduled for April 22, 2011. 	DHCS Duplicate Service Report – You will notice that services show up on this report at times without a HCPC code. If it is not a medi-cal billable service, then you don't need a modifier on it. Note that case management (94510) will at times be missing a HCPC due to a claiming workaround being used by Fiscal. These services DO need a modifier entered though.	
	Phase II Denials Report – 835s sent from the State cannot always be posted back in Avatar for a variety of reasons. For this reason, the report <b>Phase II Denials by Program</b> will not always show 100% of the denials received. The only other viable option at this time is <b>Phase II Denials by Posting (Rebill)</b> , which we know is very slow.	
	There is a patch in QA at Netsmart to hopefully resolve the issues of reports timing out due to Avatar locking. As soon as it is ready, we will load it in our TEST system.	
	The Report Inventory document on the Avatar Website will be updated and the obsolete reports are going to be removed. Please send an email to the Avatar mailbox if there is an obsolete report on the list that you still use and we can review other reports that may better suit your needs. Please let us know by April 30th if one of these obsolete reports is still needed.	
	We received a request to add Service Coordinator to the Provider Last Service Report. When we are through with our UAT preparation, we will look at getting this added. As always, thanks for these types of suggestions, and if you have others, please send them to our box.

	A. Yes, it is minimal but we do have some payments. Fiscal will attempt to provide a list of insurance companies that are paying. It can also be found by running the Client Ledger Report.

- Q. Should I run both reports to check for duplicate services?
- A. Yes. The DHCS Duplicate Services and Duplicate Services Report should both be used to check integrity of data entry.
