 CSI Update CSI submissions are continuing to proceed. Error rate has been creeping up, but is still not at a concerning level. 	Dawn	1:05 PM	5 min
 Claiming /Fiscal Update 5010 cutover status- Netsmart made the system changes in our live environment so that we can start claiming in the 5010 format. We are working on the set up that needs to be done before we can claim in this format. We can't do any claiming while making these changes. Claiming Status- We are done claiming for September 2012 services. We are receiving a ton of claims correction spreadsheets and processing them within 2 weeks of receipt. The voids/replacements will be claimed as soon as we have made the changes necessary to claim in the 5010 format. Posting 835 Status- We have approximately 4,000 835s left to post on the MH side before we are completely up to date with posting. CO*29 denials- There were 3 files that were sent to Medi-Cal in March & April 2012 without delay reason code. Because the delay reason code was left off the files all of the services were denied for CO*29. We are asking for permission from the state to use a delay reason code and submit these services as replacements. CO*A1 N480 denials- We've received clarification from the State on these denials.  Service Code Changes- There are CPT code changes that affect Mental Health services as of 1/1/13. We are working on testing to see how these changes will affect the system. We may need to add new service codes. There will be more to come on this one.

• Stephanie mentioned new CPT codes. Netsmart has not released a patch that would accommodate these new codes. There are several CPT codes with evaluation management. AMA separated these new service codes. We are preparing to accommodate these new procedure codes. We bill medical in HCPCs. Does not impact medical claiming. The new CPT codes will allow you to indicate what's called additional complexities. Fiscal and QM and program are working on the best way to implement. It will impact the medical service codes. Reasonable with the February release some more information will be available to you. We thought it would be best to inform you of these changes even though we are not able to provide valid information. The idea is we will not be able to do this in January. Once they release the patch and we finish our testing. Additional information will be provided going forward
