Claiming/Fiscal Update <ul style="list-style-type: none">• Claiming Status - done claiming January 2014 and up to date on all CCSs and Retros. If you have something outstanding please send in an email so we can research.• Medicare Risk HMO (OHC=F)- we heard some other counties are getting denials even though they shouldn't be. The state is working on it. It is an insurance that we shouldn't have to claim to. Use 44444 guarantor for NTP providers and put NotRequiredfor policy number field. For those providers who are not NTP please add the other health care coverage so we can claim to them.• New Denial Reasons – handout – new changes are being implemented with DHCS as of any services that are claimed on or after Monday March 10th, 2014. The handout is the information notice that DHCS issued. It shows old denials, changes, and the new ones. Avatar and the Phase II code list will be updated.
