<p>Upcoming Project Activities</p> <ul style="list-style-type: none"> - New URL coming ~ July - moving to the Cloud environment. There will be a redirection page and we will communicate as early as possible. - DSM V and ICD-10 A bill was passed that postpones this for one full year to 10/1/2015. We will still be working on this, but this gives us some breathing room. There will be significant changes in Avatar - Medicare Implementation approved for Medicare production claims. Some changes will have an impact on MHTC such as Service Codes. - Lab request and Results via Order Connect there will be 3 labs that we will be working with, first lab will be Quest with an ETA of July 1st. John will look into how it will effect OP. - Progress Note Entry – cannot put in a note date because MHTC uses Independent Note, but supervisors want a record of when notes are being entered. John will look into the widget to see if it can pull up the Incident Date. - Clinician Note Types – two are in UAT waiting for MHTC review. - Select Client field – goes away as typing id number or name – this is a known issue and is frustrating. - Narrow down episodes showing– change in Preferences/Chart/Show Open Only. - Progress Note - template “Inpatient Treatment Summary” – wanted to show as a form on the left side of the chart – not feasible - but can retrieve it by Note Search – to access all notes hit space bar and enter in the “word or phrase to search for” field.
