Will begin our July 2015 in September which may take longer since we now have new CPT codes. - We are also up to date on 835 and Corrections spreadsheets. - Rates are still being entered up to this date so you may see services with \$0. Please let us or your contract monitors know. - Reviewed Phase II code list and modifiers to use. - Service Code 95510C is to be used for corrections for Crisis services that were provided before July1, 2015 but are being corrected after July 1 - Remind your practitioners that after Oct1 if there is not an updated diagnosis we will get an error on our claim. ICD-10 <ul style="list-style-type: none"> - Known Issues- See Known issues document. - It is appropriate to Edit if you are not changing anything in the diagnosis. - We have found that we cannot give Read only access to the diagnosis. There is a security issue that needs to be resolved before we can update roles to give back access. - People have been used the left hand side part of the chart view to access the diagnosis information.
