There is approximately \$10 million of unspent MHSA Prevention and Early Intervention funds and \$9 million of MHSA Innovation funds in jeopardy of reverting to the State. The Sacramento County Mental Health Board provided a list of programs/recommendations to Dr. Ryan Quist for utilizing the unspent MHSA funds, which included funding for maternal mental health services. Service gaps identified through the work of the new Criminal Justice Reform Committee could also be considered for the unspent funds. |

The Project entails: Screening all DUI participants for possible poly substance abuse problems (including problems with opioids), a secondary assessment for those participants who are willing to move forward with the project, having clients meet frequently with a DUI MAT Counselor (Case Manager) who will refer to MAT services and treatment as appropriate, and completing follow-up services including any and all referrals for issues identified with the client. |
