The Community Wellness Response Team (CWRT) is a mental health counselor & a peer with lived experience that receives mobile response requests from 988 that may benefit from in-person de-escalation services, assesses needs and risks, creates safety plans, links to ongoing services, provides voluntary transport to urgent/emergency resources, and accesses Mobile Crisis Support Teams & other emergency responders when necessary. The CWRT Advisory Committee is a subcommittee of the Sacramento County Mental Health Board.
