It can be said that the motion was hasty that resources to do the project was not considered. Also, that there is new information in that an executive summary has been completed which is much more accessible and easy to understand for youth. Also there's a youth friendly powerpoint and presentation done for the BHS Advisory board available for any youth to use, changing the need for doing a youth friendly report. - June Have CBOs present on their perspective on disconnects and talk about their experience.
- July Meet with Youth and Family Advocate Committees, (CSOC attend their meeting) and have YAB attend CSOC July meeting for their perspective. Ann to contact Sydney for scheduling.
- August Committee approves outline and have AB2083 presentation.
- September Write the report
- October CSOC approves the report
- December MHB approves the report at a special session.
- Action plan for implementing recommendations for CSOC and MHB; develop plan for implementation to be done in February.
- Start developing parent outreach plan in March
- Invite Melissa Jacobs and Dawn to CSOC for February meeting. Ann assigned to this task.
- Invite Victoria Flores/SCUSD to CSOC for April meeting.
- Talk to Melissa Jacobs to ascertain what districts use the referral system. Melissa Jacobs stated she thinks all would refer to the county when appropriate.
- Talk to Chris Williams/SCOE to invite clinicians from the centers of wellness. Chair Rodriguez assigned to this task.
- Ask Melissa Jacobs on best CBOs to present, ethnic specific providers, LGBTQ+. Melissa Jacobs suggested to talk with Mary Nakamura specific to trauma informed African-American (PEI) project. Also La Familia is a FIT provider and is a staple of the community in South Sac as well as Heartland.
- Contact CBOs assigned to Silvia, Ann and Jasmine.
