### Agenda Item

- I. Welcome and Introductions, Loran Sheley
  - Chair Sheley convened the meeting at 12:05pm and introductions were made.
- II. Discussion/action item Review and Approve July 2022 General Meeting Agenda, Loran Sheley
  - The members reviewed the draft agenda for the July 2022 General Meeting.
  - Member Arneill moved to approve the draft agenda, seconded by Member Sako. Passed unanimously.
- III. Executive Committee Updates, Executive Committee Members
  - a. Updates on 2022 Presentations and select presentation/s for August 2022
    - For CalAIM presentation, the members voiced their desire for a comprehensive presentation, not wanting the presentation to be cut short. Chair Sheley asked if there's a certain element of CalAIM that the members would like to focus on.
       Member Arneill responded that she has a sense of the CalAIM elements and can give it the group by Monday to think through. Chair Sheley to ask Dr, Quist on his thoughts on scope of time for the CalAIM presentation.

  - b. Update on potential CARE Court Special Meeting
    - Chair Sheley checked in with the members on next steps for a CARE Court Special Meeting. Member Arneill stated it's now late for substantive feedback and that the board can hold a meeting to educate members on it. Currently, the bill is still being amended to possibly a pilot project instead of statewide program. The committee may want to see how it comes out of judiciary today to see how big it's going to be. A presentation at a board meeting may be more appropriate when it's signed into law.

  - Chair Sheley asked if bylaw changes should go to Executive Committee before going to full board. The members agreed. Member Arneill will draft the bylaw changes and get it to Chair Sheley for the Executive Committee agenda.
