Tests of drugs seized indicate 97% of street-purchased pills are counterfeit and 97% contain fentanyl. The amount of fentanyl contained within a single pill can kill. There will be a Fentanyl Safety Awareness Fair on November 6 from 11 a.m. – 2 p.m. (see <a href="#">Attachment A – Fentanyl Safety Awareness Fair flyer</a>).</p> <p><b>Koby Rodriguez, SC member:</b> The Sacramento City Police Review Commission and the LGBT Center are hosting a conversation regarding a policy developed by the LGBT Center and the ACLU regarding Sacramento Police Department interactions with the transgender community. He is transitioning to another leadership role and the DHA primary seat will now be filled by Julie Field. We also welcome Carmen Briscoe, who will now fill Julie’s former seat as DHA alternate.</p> <p><b>MHSA Updates</b><br/>           Dr. Ryan Quist, Behavioral Health Director, provided the updates below:</p> <p><b>COVID-19 Update</b><br/>           We have seen in our county data a great drop in COVID rates. Now that drop is levelling off. Although rates are better than the recent past we are still at higher rates than we want. We continue to encourage everybody to get vaccinated. If you have concerns about that or have questions, please talk to a health care provider you trust.</p> <p>Beginning October 1, all our direct service providers are required to be vaccinated or to have an exemption for religion or health reasons. |             | <p>behavioral health services to verify employees' vaccination status.</p> <p>As discussed at recent meetings, before COVID-19 we had a work force shortage and after COVID-19 we entered a workforce crisis. Now, that crisis is melting down as individuals leave our workforce, so we continue to have workforce challenges related to delivery of behavioral health services.</p> <p>To our providers, I know this adds to the challenges you face with staff recruitment, but I want to thank you for the hard work you do and for continuing to meet the needs of our community.</p> <p><u>Fentanyl Awareness Day</u><br/> I want to expand on what Andrew said during announcements regarding Fentanyl Awareness Day and the importance of Narcan. When somebody has an overdose, Narcan is a remedy to that overdose situation and it can be administered by anyone, including a family member, ambulance driver, or service provider. It does not have to be a nurse. For service providers, Narcan kits are something you want to have in case you see one of your consumers experience one of these really tragic events. It can be an instant solution to help that person in need and we will be giving these kits away free at the Fentanyl Safety Awareness Fair.</p> <p><u>Flu Season</u><br/> Flu season is approaching and it will be very important this year to try to avoid emergency room visits. We do not want to overrun them with COVID and flu, so this is a good year to get your flu shot.</p> <p><u>Afghan Refugees</u><br/> We have a number of Afghan men, women, and children expected to resettle here. We are working with other county partners to identify the resources and supports needed for those individuals who are coming to our county. We want to make them at home.</p> <p>We are working with our managed care plans in working towards enhanced care management and "in lieu of" service, now known as Community Support Services.</p> <p><u>Residential Treatment</u><br/> Another exciting announcement is that WellSpace has been selected as a provider for our new methamphetamine residential treatment program. The Board of Supervisors has provided us with authority to contract with them and we look forward to that program coming to our community soon. Currently we are aiming for a July 1<sup>st</sup> opening date.</p> |

Nominations for One (1) Co Chair Executive Committee Seat</b></p> | <p>Ebony Chambers, SC Co-Chair, introduced this agenda item.</p> <p>Co-Chair Daniela Guarnizo has taken a leave of absence. She plans to continue her role representing the Consumer/Family Member At-Large seat upon her return. Her alternate will represent that seat in the meantime. However, we now have a vacancy for one Co-Chair position.</p> <p>Julie Leung, Acting MHSA Program Manager, provided further context.</p> <p>The MHSA SC elects two Co-Chairs for two-year terms. The Co-Chairs lead SC meetings and are seated members of the six-member Executive Committee that develops the SC meeting agendas. The Executive Committee is comprised of the two SC Co-Chairs, the Behavioral Health Director, and three elected steering committee members. Currently, the committee membership is Ebony Chambers, Dr. Quist, Koby Rodriguez, Leslie Napper, and Ryan McClinton. SC members are being asked to put forth nominations for one Co-Chair position, with an emphasis on consumer or family member representation. See <a href="#">Attachment F – MHSA Budget Update and Recommendations presentation</a>.</p> <p>The recommendations put before the SC for consideration:</p> <ul style="list-style-type: none"> <li>• Increase provider pay rates by 7% across CSS and PEI programs</li> <li>• Implement Peer Certification with three new County Peer Manager positions</li> <li>• Increase Full Service Partnership (FSP) capacity, both new and expanded</li> <li>• Transition Mental Health Urgent Care Clinic Innovation project to CSS funding in 2022-23</li> </ul> <p><b>Member Questions and Discussion</b></p> <p>What is the amount contracts would be increased?<br/> <i>Dr. Quist: Contract dollar amounts would be increased to the point providers are able to increase the rates they charge us by seven percent, which will hopefully allow them to recruit and retain more staff.</i></p> <p>Will providers be reviewed to ensure compliance?<br/> <i>Yes, providers are already reviewed at least monthly in addition to quarterly reviews.</i></p> <p>Speaking as a provider, I would add that also includes review of our annual agency-wide audits.</p> <p>I found this presentation to be clear and concise. The peer program is absolutely what folks are asking for and the mental health urgent care provides a great service to the community, so continuing that makes a lot of sense to me. The need is evident and I support all of these recommendations.</p> <p>Why was AOT not mentioned? Why was there no consideration for funds for that?<br/> <i>We brought the question of MHSA funding for AOT before the SC earlier this year. The SC vote taken at that time indicated the SC did not believe MHSA funds should be used for this. I want to be fair and clear that the vote taken was not in regards to SC support for or lack of support for county implementation of AOT, but solely about the use of MHSA funds for this purpose. After the SC vote, the separate question of AOT implementation went before the Board of Supervisors and the Board voted unanimously in favor of implementing AOT in Sacramento County. Dr. Olivia Kasiryse seconded.</p> <p><b>Public Comment</b></p> <p><b>Diane Wolfe, psychiatrist</b> (via chat): I am concerned a seven percent increase may not be enough to recruit and retain qualified staff.</p> <p><b>Angelina Woodberry, Adult Consumer Advocate Liaison:</b><br/> There is concern over the lack of consumer awareness and involvement in the upcoming adult system of care transformation. The details are not available to consumers and we cannot understand why.</p> <p>Also, what program areas will the three peer manager positions be in? That could be a crucial thing for SC members to know as you move forward.</p> <p><b>Robin Barney, Adult Family Advocate Liaison:</b> Thinking about the peer positions, I know you gave us an annual salary base but I wonder what that breakdown actually looks like. We want to ensure the peers are receiving equitable pay, that they are getting their due.</p> <p><i>Regarding the peer positions, the amount would include salary and benefits and their work would include supporting peer certification and the rollout of a new Medi-Cal funded peer service across the system. An already funded but currently vacant health program manager position within the BHS Administration, Planning and Outcomes Unit would be designated for oversight of this process and MHSA planning and would also be filled by a peer. This would not be the extent of their job duties. BHS is open to community feedback on what other duties these peer manager positions should take on.</i></p> <p><b>Motion Restated</b><br/> <b>Christopher Williams moved to support the recommendations within the presentation. Dr. Olivia Kasiryse seconded.</b> Erin Johansen suggested a friendly amendment to the motion on the floor, raising the amount of increase from seven to ten percent. Ebony Chambers seconded this amendment. This friendly amendment was accepted by the motion authors.</p> |

General Steering Committee Comment</b></p> | <p><b>Karly Mathews:</b> I am a SC member and also receive services in Sacramento County from one of the contracted providers through MHSA funding. I need to say I am not satisfied. Often over the last ten months the voice mailboxes have been full and I have not gotten a call back for weeks or months at a time. It is extremely hard to navigate, even though I have trained on finding resources and navigating health systems. I called the provider only to be told I had been dropped because the employee assigned to me had left. If this is happening to me, I know it must be happening to many others.</p> <p><i><b>Dr. Quist:</b> Please send me an email. I want to ensure you are being supported at this point. I would be happy to help with that.</i></p> <p><b>Jane Ann Zakhary:</b> We just learned that there have been technical difficulties with the Zoom call for some tonight. Some people were stuck in a waiting room that staff were unable to see or admit to the meeting. For anyone who had trouble joining or participating at any point tonight, I truly apologize. We did not realize this was happening and are not sure why, but we will look into this to try to avoid this in the future.</p> <p><b>Leslie Napper:</b> One concern I have is in regards to the compensation for the peer managers. If nothing has changed from when it was originally put out, I think we should address that. However, I am very excited that the county is open to hiring a peer as a health program manager. That is amazing and forward thinking and I hope the trend continues.</p> <p>Also, is there any consideration of increasing adult outpatient services? I think there is a general concern as to whether we are allotting enough to provide the behavioral health services the county is charged with given all that is on our table: outpatient providers, FSPs, Alternatives to 911, to outpatient services--whether PEI or otherwise--and the same for AOT, etc., and then just in general, given that we are redesigning our programs. 

## Sacramento AA/Black Community Dialogue: Mental Health and Criminal “Justice” System

ONTRACK Program Resources, Inc. (ONTRACK) has contracted as a “Local Level Entity” (LLE) subcontractor with the California Black Health Network (CBHN) under the California Pan Ethnic Health Network’s (CPEHN) Mental Health Services Oversight and Accountability Commission (MHSOAC) *Diverse Stakeholder Engagement* contract. In its role as a LLE, ONTRACK is contracted to coordinate two annual events to engage the Sacramento African American/Black (AA/Black) community and develop a post-events report. The events will include robust collaborative planning, outreach and engagement with county and community partners and leaders.

ONTRACK is organizing the events to engage the Sacramento AA/Black community and representatives from the behavioral health and criminal justice systems and county/city governance in a discussion about AA/Black mental health needs. The events will focus on mental health needs as addressed (or not addressed) through local criminal “justice” systems involvement (i.e. police, sheriffs, jails, juvenile “justice,” probation, parole, courts, referred provider network, etc. (law enforcement)) agencies/systems. The first event has been slated to take place November 17 and 18, 2021, 2-5 pm, and, due to Covid-19, will be conducted virtually. The second event will take place in the fall of 2022 and hopefully will be able to take place in person (TBD).

### Background

In early 2020, CPEHN originally proposed that an LLE organize an introductory general topic event with the Sacramento County AA/Black community addressing public mental health services and the MHSOAC, through its MHSOAC *Diverse Stakeholder Engagement* contract. However, Sacramento County Behavioral Health Services (BHS) has recently engaged the AA/Black community extensively through its *African American Trauma Informed Wellness Program (TIWP)*<sup>1</sup> and *Behavioral Health Racial Equity Collaborative (BHREC)*<sup>2</sup> development process involving numerous community listening sessions. And, it has been determined that an introductory/general topic type event would be redundant. Therefore, ONTRACK is recommending to address a topic that has been raised in these and comparable sessions with the local AA/Black community: the experience of AA/Black people with mental health needs and the local criminal “justice” system. This topic remains a top concern for the AA/Black community and ONTRACK, in its role as a trusted community partner and as a seasoned technical assistance provider, believes it can help facilitate a discussion that will be beneficial to the AA/Black community and to others concerned.

Another reason this topic has been selected is to be sure that the AA/Black community is

aware of and engaged in other important and relevant recent BHS developments, i.e., the Sacramento County MHSa funded *Innovation Project 5 Plan: Forensic Behavioral Health Multi-System Teams*<sup>3</sup> contract recently awarded to El Hogar; the *Wellness Crisis Call Center and Response* (formerly *Alternatives to 911 for Mental Health*)<sup>4</sup>, and the recent adoption of *Assisted Outpatient Treatment (Laura's Law)*.<sup>5</sup>

### Proposed: Two-Part “Call and Response” Virtual Event

Over the last several years, the Sacramento AA/Black community has repeatedly expressed its frustration and outrage with local encounters involving behavioral health and law enforcement, in a few publicized cases resulting in the death of several Black people having mental health and/or substance use crises. The response from the AA/Black community has run the gamut from organized and spontaneous street protests, outcry at City Council and Board of Supervisor meetings, *Defund the Police*, and *Decarcerate Sacramento*, etc. And, at BHS community listening sessions, it has been consistently included as a topic of top concern. ONTRACK recognizes that the topic is sensitive, at risk of being volatile from the perspective of city and county administration. And yet it remains a topic in which engagement with the AA/Black community could use great improvement, especially given the opportunities for meaningful and collaborative input into the *Innovation Project 5 Plan: Forensic Behavioral Health Multi-System Teams* contract, *Wellness Crisis Call Center and Response* project and *Assisted Outpatient Treatment (Laura's Law)*.

ONTRACK will plan and implement this virtual event addressing the AA/Black community and mental health and law enforcement in collaboration with members of the AA/Black community and representatives from CBHN, CPEHN, BHS and provider networks, and law enforcement. The event is envisioned as taking place in two 2½ - 3 hour sessions, in the spirit of “Call and Response.” The first part of the event will center on members of the AA/Black community sharing their experiences with dealing with mental health issues across the spectrum of contacts with law enforcement and the behavioral health system (the “Call”). The gathering will be skillfully facilitated by an AA/Black licenced Marriage and Family Therapist, Dr. Tanya La Takla, with warm welcome and centering exercises, panel presentations made up of 4-5 community members, breakout groups, large group reporting out, and a closing soothing/healing ritual. It is expected that Board of Supervisors, BHS, law enforcement and other county/city/state representatives who will speak/represent at the following second session will be present (with cameras on) and listening respectfully/non-defensively to the panel presentation and large group report out. (But they will be in separate facilitated breakout groups from the community members.)

The second session will be a thoughtfully crafted session (The “Response”) beginning with facilitated acknowledgment of what was said in the first “Call” session (including summation/paraphrasing, compassion and expression of wanting to work together to address and resolve concerns, in a way that is trauma informed, validating and empowering.) This session will also include sharing information from 5-6 Board of Supervisors, Mayor’s Office, BHS and law enforcement representatives about current/future solution-oriented initiatives and how the AA/Black community can be involved in *meaningful* ways. There will be ample time for questions and answers/dialogue and next steps between this event and the follow-up event a year later (2022). We will strive to create a sense of accessibility, authentic dialogue and relatability.

The event will take place all on two consecutive days, Wednesday, 11/17 and Thursday, 11/18, at 2-5 pm. We will communicate strongly that both sessions are encouraged to be attended.

### Event Follow-up

ONTRACK, in its role as LLE, is contracted to conduct a follow-up event a year after this proposed event, in 2022, that will focus on building upon the first 2021 event. We will conduct debriefing sessions with key stakeholders to inform planning for the 2022 event, including AA/Black community panelists and selected participants; county/city/state representatives, including Board of Supervisors, BHS and provider network, law enforcement, and potential private partners. We will have monthly event planning meetings for the second annual event starting in 2022 (January).
