MHSA Steering Committee Membership Background

- ❑ The Executive Committee is comprised of six (6) Steering Committee members who serve a maximum of two years.
 - ❑ The Executive Committee to elect two members each year to backfill members who are terming out.
 - ❑ One Executive Committee Co-Chair shall be voted in to replace the co-chair that is terming out.
 - ❑ One of the Co-Chairs must represent a client, family member or caregiver seat.
- ❑ The Selection Subcommittee is comprised of four (4) Steering Committee members and serve a one (1) year term.
 - ❑ The election cycle coincides with the annual Executive Committee election.
 - ❑ Must ensure 50% of the selection committee is comprised of client, family member or caregiver.

Steering Committee Nominations for:

- ❑ One (1) Executive Committee Co-Chair
 - ❑ **Term: July 1, 2024-June 30, 2026**
- ❑ Two (2) Executive Committee Members
 - ❑ **Term: July 1, 2024-June 30, 2026**
- ❑ Four (4) Selection Subcommittee Members
 - ❑ **Term: July 1, 2024-June 30, 2025**

MHSA Steering Committee Consumer, Family Member/Caregiver Term Periods

Reminder:

For the purpose of staggering membership turnover, individuals who joined the Steering Committee:

- ❑ Prior to 2016 - term end on July 1, 2024
- ❑ Between 2017 and 2019 - term end on July 1, 2025
- ❑ During 2020 to July 1, 2023, - term end on July 1, 2026

*Note: Alternate members will fill in behind members who term out. Consumer and Family Members/Caregiver representatives may reapply after their term has expired.
