5:16 pm - Guest Presentation: Staci Dao -Tammira Staci presented their new application for mobile devices.

• Staci Dao, founder of Tammira, recently introduced an innovative new app with powerful features designed to enhance meetings and events. The app boasts live streaming capabilities, interactive modules, and polling tools—perfect for engaging participants in real-time. Staci encouraged the board to explore the platform, suggesting it could be ideal for upcoming meetings or any other events we may have in the pipeline. She shopped the ideas of utilizing it to live stream a BHYAB meeting or session in the future.

5:33 pm - Board Activity

- The board divided into two groups (online and in person) to begin drafting a policy brief. They analyzed survey data and identified a significant gap: while 64% of respondents noted school counselors as a resource for substance misuse prevention (Question 15), only 15% reported feeling comfortable talking to counselors about mental health/wellness (Question 20).
- Board members noted the higher responses of P2P methods such as friends and siblings (45%). Even family members came in at 33%, twice as high as the school counselor.
- Board member Radha noted that there is a "Lack of education on substance use in school", and that "schools need to have more caring adults on campus".
- Board members noted that P2P methods work best.
