- The BHYAB officially voted on their 3 policy brief ideas and recommendations for their policy brief
  - With suicide being the second leading cause of death for youth, and with LGBTQ+ youth experiencing greater disparities in depression than their cisgender, heterosexual counterparts, we need to better track health data for SOGIE (sexual orientation, gender identity, and expression) students and make data-driven decisions to accurately allocate resources to those students through targeted programming and support

- Fund and require that culturally competent health education courses for students include information on mental health, allowing schools to provide mental health and equity training for students and staff.
- In a world where 8 out of 10 young people surveyed are looking to learn coping skills to help them deal with the stresses of everyday life, we need more mental health practitioners on school campuses to increase capacity for direct intervention and peer-topeer programming.
- The board voted to create subcommittees to develop "data reports" for their policy brief
- Motion to vote board member Audrey Nunez to be the administrative subcommittee was approved
