The reimbursement rates (effective 7-1-19) for Wrap will be based on a rate of \$13,532 for non-federally eligible youth and \$6,766 for federally-eligible youth. The following scenarios show the specific reimbursement rate for each placement level:

Adoptions Assistance Program (AAP) Payments:

- A. AAP payments are an agreed upon amount paid to the AAP parents with renewal every two years. The Department of Child, Family and Adult Services Adoption worker will determine the appropriate reimbursement rate based on eligibility information, federal or non-federal.
- B. The reimbursement rate for Wraparound providers for AAP clients who are residing at home is based on non-federal Wraparound rate minus the cost of payment to AAP parents.

Payment to AAP parent: \$1,000/month (could be higher)

Wrap provider will receive: \$12,532/ month
Total cost per child: \$13,532/ month

C. Payment authorization for an AAP Wraparound case is effective for 12 months. Adoption Wrap case requires both SC123X and AAP 2 in order to pay Wrap funds to Wrap provider Wraparound provider requests an extension by contacting the Wraparound Program Coordinator. Wraparound Program Coordinator sends extension request to DCFAS Adoption DHA Eligibility worker.
