## Our Mission

To provide a culturally competent system of care that promotes holistic recovery, optimum health, and resiliency.

### What are Wraparound Services?

Wraparound is a strengths-based, youth and family centered, needs driven, intensive service that enables youth with the highest level of need to remain in or return to their home or to another permanent family setting. Wraparound services are also essential in helping to ensure stability of placements.

# What is the purpose of Wraparound Services?

The purpose of Wraparound is to provide eligible children and youth with familybased alternatives to inpatient or shortterm residential care, and to help stabilize current family-based placements, and reduce hospitalizations, child welfare involvement and/or law enforcement involvement.

- Youth Placed into Protective Emergency Placement (PEP)

- □ Youth diverted from court processes after a citation or arrest
