BHS Overview of Programs and Summary of Current Initiatives</b>	<ul style="list-style-type: none"> <li>- Stephanie Kelly, Anantha Panyala and Christina Irizarry presented on the Court/Justice Involved, Acute and Crisis programs in Sacramento County.</li> </ul> <p>Member Comments/Questions:</p> <ul style="list-style-type: none"> <li>- Member Mummert <ul style="list-style-type: none"> <li>o Q: Is the Co-Response Crisis Intervention Team (CCIT) program currently partnering with the Sacramento County Sheriff's office?</li> <li>o A: No, CCIT is working with other law enforcement agencies and Sacramento City Fire.</li> </ul> </li> <li>- Member Wentzel <ul style="list-style-type: none"> <li>o Provided a reminder that CARE Court and Assisted Outpatient Treatment (AOT) are civil court programs and not criminal court programs. This structure will be revisited in 3 months to see if the committee members are still interested in an informal leadership structure.</li> <li>- It was clarified that with an informal leadership structure, County staff will facilitate the meetings and prepare the agendas.</li> </ul>
