Co-Chair Avey shared the FAQ for Budget Engagement & Advisory Best Practices, provided as a handout and linked as an attachment to the minutes. Additionally, Co-Chair Avey recently attended the groundbreaking ceremony for the new Mental Health Rehabilitation Center (MHRC) to be constructed by WellSpace Health. Summary of Discussion

Shanece Okoro Duncan, BHS Program Planner, provided an update on total number on referrals received from the jail, jail placements for residential treatment, and drug trend usage. She shared concerns regarding court delays resulting in follow-up screening, which further delays placement for treatment. Reminder about the Fentanyl Summit on May 12th. Shanece also responded to questions related to 290 registrants and residential placement.

5. 988, CWRT, and CRBH Updates

Presenters: WellSpace Health & Bay Area Community Services (BACS)

Discussion

Summary of Discussion

Representatives from WellSpace Health and BACS provided March program updates on 988, CWRT and CRBH, including success stories, call data, staffing numbers, and outreach efforts. Representatives also responded to questions from the committee.

Public Comment

- Christie Gonzales, with WellSpace Health, provided a public comment to clarify from her previous public comment at the general meeting that CRBH services were not traditionally funded by the formerly known Mental Health Services Act and therefore not written into the Behavioral Health Services Act Plan. She added that while 988 federal dollars allow WellSpace Health to answer calls, the coordination, data gathering, technology, etc. work is not included in the BHSA plan and will no longer be funded after July 1st.
- Stephanie Kelly with Sacramento County BHS clarified for the committee that the funding for the WellSpace Health Suicide Prevention and Crisis Line contract will no longer be funded after July 1st because it was replaced with 988, which is funded by the State. MOUs have been developed in collaboration with WellSpace Health and going to the Board to continue the strong collaboration between WellSpace Health 988 and CWRT, which will support ongoing coordination, data gathering, and access to CWRT technology (BHL).
