Welcome, introductions and announcements – Paula Lomazzi	Paula Lomazzi welcomed all to the meeting, facilitated introductions, and reviewed the packet of materials for today's discussion.
	 Announcements Marcia Jo is unable to attend today's meeting but she submitted a program status report which Nancy Gilberti will present.
Health Care for the Homeless Conference Report Back – Paula	Paula Lomazzi presented a PowerPoint "National Healthcare for the Homeless Conference Report Back" A copy is posted on the website.
Lomazzi	 Universal Health Care: Health Care for All is working an initiative for Oregon's 2020 ballot for universal health care. However, federal restrictions make it difficult to enact universal health care statewide. Empowerment in Consumer Governance: Consensus decision making is recommended for consumer advisory boards. Clinicians often recommend members. Activities get members involved. Governing boards make decisions and advisory boards offer recommendations. Most organizations have both governing and advisory boards. Framing: Discussed how to convey messages since how an issue is framed can determine support. Trauma Informed: Shared how best to interact with people who have experienced trauma. Vince Gallo added that he once asked Friendship Park directors, "What is the single most common denominator of all homeless people?" and they said "trauma" so he has always remembered this in his dealings with clients. No Safe Place - Criminalization of the Homeless: Presented alternatives and action steps.
Member Recruitment Strategies – All	The board discussed formalizing a sign tailored to this board's needs and developing a packet to hand out to interested persons. The packet would include a brochure about the board, contact information, and an application. Mike Blain recommended contact information be prominent on the signs and that they be posted where potential members have to wait. Sally Ooms suggested an information table at Loaves and Fishes.
	Paula Lomazzi, Sally Ooms, and Nancy Gilberti will meet to draft materials for the board's review.
	Rebecca Hahn asked about inviting potential consumers to attend a future meeting with her. Nancy responded that members of the public are certainly welcome at any board meeting, and that it would be also be desirable for the person to get in contact with Nancy or Paula who can talk to them and provide information. Nancy will send out an updated board contact list.
