	Announcements: Karen Giordano has been temporarily reassigned to cover the county's Refugee program. She should be back in November. Refugees meet the federal definition of homeless and this committee may want to learn more about them at a future meeting.
	The Department of Justice filed a statement of interest earlier this month arguing that making it a crime for people who are homeless to sleep in public places, when there is insufficient shelter space in a city, unconstitutionally punishes them for being homeless. This committee may want to endorse the statement and send a letter of support to the City. Paula will provide more information at the next meeting. She encouraged members to send her ideas about this topic.
Quality Improvement Council (QIC) activities – Marcia Jo	Marcia Jo facilitated discussion of the county's Quality Improvement Council (QIC) activities and review of data reports for May, June, and July 2015. QIC members include the primary care Medical Director, Pharmacy Director, Program Manager and administrative staff.
	Areas measured are those from the HCHAB approved QIC Plan and include: Access to Care, No Show Rate, Mercy Clinic Loaves & Fishes Utilization, Pharmacy services, and Clinical Outcomes for Diabetes Management.
	The committee reviewed and approved the indicators and the data reports.
