Per CCS Sacramento County guidelines, all clients must have a current medical report, physical therapy evaluation and occupational therapy evaluation to remain active with CCS MTP.

It is imperative that all scheduled appointments are attended to maintain current medical records and provide quality therapy services. Please call and cancel any appointments that you and the client are unable to attend **prior** to the scheduled appointment. As a reminder, face coverings are still required for everyone in healthcare settings. If you have any questions about the attendance policy, please contact the MTU supervisor.
