Welcome and Introductions	Meeting began with introductions at 12:05 p.m.
Minutes Review of August, 2012	August 2012 minutes approved unanimously; moved by Edward Lewis and seconded by Ray Wilson.
Presentation	<p>Chronic Disease Prevention Presentation by Yvonne Rodriguez. The Tobacco Control Committee meets on November 14, 2012 and is seeking a retailing license enforcement policy, Youth Purchase Survey (YPS), to be adopted by local cities.</p> <p>Medical and CHDP requires lead poisoning testing in toddlers. Health educators are working with providers to improve daycare services.</p> <p>Efforts to educate the community on nutritional and physical fitness and underway. Working with retailers to provide fresh produce in stores.</p> <p>Also underway are efforts to eliminate smoking in apartment complexes. Also targeting secondhand smoke at the Sacramento State campus.</p>
Public Health Division Update	<p>The Public Health Division report was presented by Dr. Kasirye.</p> <ul style="list-style-type: none"> • The Governor signed AB2109. This requires parents to get education and signature from healthcare provider before they can sign personal belief exemption form for child's vaccination to meet school requirements. Governor asked for separate signature for religious exemption. • Cottage Food bill AB1616 passed allowing food preparation in private homes which is for sale to the public. Begins January 2013. • West Nile Virus cases are decreasing. We had a total of 15 cases and two deaths. • We did not get any confirmed Hanta virus cases, though there were two cases with preliminary positive results

They will issue Notices of Action with eligible dates of 11/01/12. Covered services to LIHP enrollees begin within the LIHP network 11/01/12. There are several primary care medical homes including local FQHCs and Medical Groups. Committee was particularly interested in the eligibility processes. A panel is scheduled for October 22, 2012 meeting to include County DHA Eligibility, State DHCS (default algorithm) and Health Care Options. • Mr Monasky discussed selection of a new PHAB member for the Committee.
