ADULT CORRECTIONAL HEALTH

 <u>COVID-19 for Jail Facilities</u> – Last week's dashboard had a net increase of 31 cases with 3 at MJ and 29 at RCCC. 4th outbreak. Issues – high ADP, very contagious Omicron variant.

- <u>COVID-19 Vaccinations</u> Continued slow uptake. As of 7/27/2022, 3,139 inmates received at least one COVID-19 vaccine dose.
- Vacancies = N = 62.0
 - June BOS approved addition of 39.0 FTE at budget hearings.
 - June/July Contract negotiations with (3) labor groups concluded for health services contracts.
 - July Positions were created by Personnel in mid-July.
 - July BOS approved labor agreements for nursing and physicians/dentists.
