Inmate Vaccination Data

As of 5/25/22, 3,044 inmates received at least one COVID-19 vaccine dose.

- Net increase of twelve (12) new inmates receiving initial doses.
- Net increase of eight (8) 2nd doses
- Net increase of three (3) booster doses.
- Total of twenty-three (23) doses provided this past week.

Inmate Vaccination

All inmates are eligible and encouraged to receive vaccinations including booster doses. Staff also complete the vaccination series for inmates who transfer to the jails partially vaccinated. Due to the high rate of jail releases, staff also periodically review point in time vaccination data shown below:

For the 04/27/22 point in time report, staff pulled length of stay data for inmates who received at least one COVID-19 vaccine dose. Of the 879 who received at least one dose of the COVID-19 vaccine, **90%** have been in custody for more than 30 days.



Nurse Intake



Nurses completed an average of 2,353 intakes per month for FY 2021/22 YTD. Nurses complete an intake for all bookings. About **30%** of the intakes for each month met the definition of homelessness. RN must mark "housed" or "homeless" at intake.

<u>Homeless Definition</u>: living in a place not meant for human habitation (street, car, river, camp, etc.), shelter, transitional housing, or exiting other institution where they temporarily resided (less than 90 days).

Chronic Health Conditions

Daily Population Snapshot for April 27, 2022 = 3,319

Of the 3,319 adults incarcerated, **69%** of the ADP had chronic health conditions. Of those with chronic conditions, **65%** had two or more chronic health conditions.
