# Novel Coronavirus:

- Sacramento County has had a total of 339,292 reported cases of COVID-19 and 3,395 deaths due to COVID-19 since February 2020.
- The current case rate is 19.3 per 100,000. The rate has been decreasing recently.
- Sacramento County Public Health (SCPH) continues to strongly recommend vaccination and masks in public places.

# MPX:

- The World Health Organization has signaled their intent to rename the virus. In the meantime, we are referring to it as MPX (sometimes pronounced M-Pox).
- 122 cases of MPX have been identified among Sacramento County residents since May 2022 (as of 8/29/22)
- Recent changes to vaccine dosage guidance can yield 4-5 time more doses per vial, which has allowed SCPH and its partners to keep up with demand. Sacramento County has received 5,908 vials of vaccine to date. 1,658 individuals have been vaccinated by SCPH (1<sup>st</sup> or 2<sup>nd</sup> doses) and 4,305 doses have been redistributed to area medical providers.
- The risk to the general public remains low at this time.

#### Behavioral Health Workforce Crisis

- Across the State, there is a Behavioral Health Workforce crisis like none ever seen before
- Sacramento County is no exception and this has impacted contracted providers, as well as County positions
- Here are some of the efforts to address this in Sac County:
  - $\circ$   $\,$  Contracted providers received a 10% increase in rates to assist with recruitment and retention
  - As a part of the union negotiations, the County is now offering a more competitive compensation package
  - Sac County accepted applications for service staff including contractors and County positions for Loan Repayment up to \$25,000 with a service commitment.
