
PHAB REPORT: Adult Correctional Health Updates

Jail Facilities Average Daily Population (ADP)



- The ADP in June 2024 was 3,237. The average for the FY was 3,153.
- Based on prior FY 2021/2022 and FY 2022/23, the highest ADP was in July 2022 (3,521) and the lowest ADP was in January 2023 (2,558).



- Onsite UCD MH staff are working with Sacramento County Behavioral Health by referring unlinked patients with SMI to the Adult Psychiatric Support Services (APSS) Clinic for continuation medication and linkage. The new Behavioral Health Forensic Full-Service Partnership began service provision in March 2022.

Chronic Physical Health Conditions


• The Daily Population when data was pulled for this report on June 26, 2024 = 3,265.

As of 7/9/24 – MJ has 338 suboxone, 13 methadone, 6 sublocade; RCCC has 311 suboxone, 12 methadone, 7 sublocade

SUD related – Note June 2024 the contract with WellSpace Health ended. Sacramento County SUPT assisted ACH by providing two staff to facilitate SUD Groups. There were 13 completed groups in June (an additional 7 were cancelled due to staff schedules, custody availability and holiday). There were a total of 167 patients seen for SUD treatment in June. This number is expected to increase in the coming months due to new contractor and being fully staffed. On average, Wellspace provided one SUD counselor – CORE has submitted clearance information for 3 staff.
