Sutter Roseville Mercy General	 -Mercy General deferred until the next meeting. -Lisa Hayhurst & Debbie Madding from Sutter Roseville present EMS to Cath Lab PowerPoint. 57 y/o female presenting to EMS with Chest Pain who self-administered nitro and ASA before EMS arrival. Inferior elevation noted. STEMI alert by EMS and activation of cath lab occurred. Ron Loomis, AHA, what was the first medical contact to first ER intervention? Looks like about 93 minutes. Dr. Garzon-EKG was at 2132 and stroke alert at 2143. When was the cath lab activated? Who decided in this case? Debbie Madding-The transmitted EKG is received by the MICN and shared with our ED provider in ER. Often they consult with a cardiologist. Ron Loomis, AHA- I notice you repeat the EKG upon arrival. If that EKG was different and didn't show the STEMI but the first one did, would you do anything different in your process?




