Approval of ProTransport-1 Ground Ambulance Fee
Schedule
Effective 1/1/2024**

The Sacramento Emergency Medical Services Agency approves the ProTransport-1 Ground Ambulance Fee Schedule, Effective January 1, 2024. The Fees are listed below.

- Basic Life Support Ground Ambulance Transport, Non-Emergency - \$2,383.55
- Basic Life Support Ground Ambulance Transport, Emergency - \$3,287.31

- Advanced Life Support Ground Ambulance Transport, Non-Emergency - \$4,100.22
- Advanced Life Support Ground Ambulance Transport, Emergency - \$5,036.41

- Specialty Care Ground Ambulance Transport** - \$12,659.95

- Ground Ambulance Mileage, Per Mile, all levels of service, \$70.80. Mileage is reported in tenths of a mile and is billed at the next mile up. (Example: 4.2 miles would be billed as 5.0 miles).

- Ancillary charges such as oxygen, nighttime, and wait time are not billed separately.

** - Note that Specialty Care Ground Ambulance Transport may include adult specialty care transport (sometimes called Critical Care Transport), Pediatric Intensive Care Transport, or Neonatal Intensive Care Transport.
