

Notable PCR Narrative Comments

- PT "experiencing increased dizziness, blurred vision, light sensitivity. Recently hospitalized for a stroke." No CPSS performed. PT hypertensive 210/118
- "Patient was in the vehicle drooling, and not speaking. Patient would follow commands but unable to speak. Patient was released this morning post stroke". Baseline A/Ox4 GCS 15 per mother on scene. No CPSS performed
- 81yo female "found wandering around house aimlessly this morning by husband and non-verbal which is not baseline" PT is hypertensive, A/Ox0, GCS 10. Narrative states "no symptoms of stroke"
- Pt had "new onset symptoms including mouth twitching and vertigo" x3 hours, "tingling left side of face". Negative CPSS
- PT with hx migraine. Post migraine "numbness/ tingling rt hand and arm, and all over her face." Negative CPSS
- PT had "new onset left sided facial numbness", hypertensive 200/103. No other symptoms, Negative CPSS.
