### **Kev hais qhov tsis txaus siab**

Ib qho tsis txaus siab yog ib qho hais txog qhov tsis pom zoo txog ib qho teeb meem uas tsis yog Notice of Adverse Benefit Determination (NOABD).

Tuaj yeem hu xov tooj mus foob hais qhov tsis txaus siab rau ntawm Member Services lossis sau daim ntawv foos hais qhov tsis txaus siab.

- Tus tswvcuab yuav tau txais ib daim ntawv lees tias Lub Chaw Pab Cuam Tswvcuab tau txais daim ntawv hais qhov tsis txaus siab lawm.
- Tus tswvcuab yuav tau txais ib daim ntawv daws qhov teeb meem rau hauv lub sijhawm (90) cuaj caum hnuv.

\* Tej zaum yuav muab lub sijhawm ntxiv 14-hnuv uas yog saib raws li qhov teeb meem ntawd.

### **Thov Hais Kom Txiav Txim Dua Raws Li Txheej Txheem**

Ib Qho Thov Hais Kom Txiav Txim Dua yog ib daim ntawv thov hais kom rov qab saib xyuas txog NOABD.Ib qho NOABD tshwm sim thaum MHP tsis kam lees saib xyuas, txo, ncu lossis thim qhov tau tso cai saib xyuas; tsis kam lees them qhov nqi saib xyuas; tsis muab cov kev saib xyuas kom ncav lub sijhawm; lossis tsis nqis tes ua raws li lub sijhawm hais qhov tsis txaus siab, thov hais kom taug xyuas rooj plaub dua raws li txheej txheem, lossis thov hais kom taug xyuas rooj plaub sai sai\*, lossis tsis kam lees daim ntawv thov them cov nqi uas tsis sib haum xeeb.

- Tus tswvcuab tuaj yeem hais kom txiav txim dua lossis sau ntawv xa mus rau lawv.Kev hais lus kom taug xyuas rooj plaub dua ntawd yuav tsum tau sau ntawv mus ntxiv, thiab kos npe rau daim ntawv thov hais kom taug xyuas rooj plaub dua.
- Tus tswvcuab yuav tau txais ib daim ntawv lees tias Member Services tau txais daim ntawv thov hais kom txiav txim dua lawm.
- Yuav tsum sau daim ntawv thov hais kom txiav txim dua rau hauv lub sijhawm 60 hnuv txij hnuv ntawm NOABD.
- Tus tswvcuab yuav tau txais ib daim ntawv daws qhov teeb meem rau hauv lub sijhawm 30 hnuv\*.

### **Thov Hais Kom Txiav Txim Dua Sai Sai**

Yuav tsum sau daim ntawv Thov Hais Kom Txiav Txim Dua yog thaum tus tswvcuab txoj sia, kev noj qab haus huv, lossis rab peev xwm yuav poob rau kis tsis zoo.

- Tus tswvcuab yuav tau txais ib daim ntawv daws qhov teeb meem rau hauv lub sijhawm 72 hnuv.
- Yog tsis kam lees txais daim ntawv thov hais kom txiav txim dua sai sai, lawv yuav xa ib daim ntawv ceeb toom tuaj rau tus tswvcuab thiab mam li pib thov hais kom txiav txim dua raws li txheej txheem.

### **Kev Muab Lus Qhuab Qhia**

Tswvcuab cov lus qhuab qhia yog ib co lus tseem ceeb pab txhawb kom muab kev saib xyuas mob nkeeg tau zoo.Cov Kws Kho Mob muaj Cov Kem Plaub Fab Muab Lus Qhuab Qhia txog feem kev saib xyuas.Zoo siab txais tos txog cov tswv cuab cov lus qhuab qhia thiab yuav raug muab tso rau hauv cov kem plaub fab, los sis muab qhia ncaj qha rau tus kws saib xyuas mob puas hlwb los sis tus kws pab tswv yim.
