SNAP-ED Update	<p>Presented by Megan Sheffield</p> <ul style="list-style-type: none"> • Specific focus on Re-Think Your Drink (RTYD) • Addressing sugar sweetened beverages • Grant term: 4 years (Oct. 2012 – Sept. 2016) • Next allocation (Oct. 2016 – Sept. 2019) • Intervention areas must meet census tract criteria – 9 Sacramento neighborhoods are currently being served. • Neighborhoods must be SNAP eligible – up to 185%FPL • 185% FPL eligibility applies to college students and elderly population as well. • Twin Rivers – New wellness policy includes new P.E. requirements in an attempt to fight the childhood obesity epidemic.

STD/HIV Program Update	<p>Presentation by Staci Syas</p> <ul style="list-style-type: none"> • Though rates are slowly decreasing, Sacramento County still ranks in the top 10 across the state for new cases of chlamydia, gonorrhea, and HIV. • Females ages 15-24 are over 6 times higher than overall county rate. • Rates for this group have been declining since 2011 • There has been a dramatic increase in cases of Syphilis over the last few years. • Trends show an increase of syphilis infection among youth. • Dramatic increase in cases of congenital syphilis. • General lack of awareness of screening and treatment guidelines among local providers. • Sexually active youth should be encouraged to be screened for all STD's annually, including syphilis. • Behavioral Health Specialist increasing screenings in mental health facilities. • Upcoming National Coalition meeting will discuss California's ability to administer "rapid syphilis testing" outside of clinics.
NFP CAB UPDATE	<p>Presented by Sheila Holcomb</p> <ul style="list-style-type: none"> • NFP is now fully staffed – 165/200 working caseload
MCAH Plan/FIMR Update	<p>Presented by Quinn Wells:</p> <ul style="list-style-type: none"> • 105 fetal deaths will be reviewed by FIMR Team • Next mtg. is March 9, 2016
Board Vacancies	<ul style="list-style-type: none"> • Sharon Saffold not available to give report. Will update at March meeting.
Board Member/Guest Updates	<ul style="list-style-type: none"> • Kate Varanelli will provide a MCDAC update to the Board of Supervisors on January 26, 2016. • The State Dental Director has convened a team to formalize a "State Dental Health Plan." • The First 5 Denti-Cal Report reflects an increase in utilization rates for children from 20% to 40% over the period of 2010 - 2015. This is still below the state average of 52%. • Dr. Moynihan highlighted the continued issue for Denti-Cal pediatric patients who need
