Public Health Officer's Report	<ul style="list-style-type: none"> • There have been 3 confirmed cases of measles in Sacramento. They have all been travel related and confined to one family. • The new County Sexual Health Clinic is now open at the 4600 Broadway location. We are still looking for a Nurse Practitioner to staff the clinic. Hours are: Wednesday 8-12, Thursday 8-5, Friday 8-5 or by appointment 916-875-1551. The Los Rios STD clinics are closed for the summer and will reopen in August • The new Governors budget included some public health related funding, 40 million for four years shared among all the CA counties.
MCAH Update	<p>Presented by Leesa Hooks</p> <ul style="list-style-type: none"> • The BIH 71-J process is complete and should begin July 1, 2019. • MCAH is partnering with Behavioral Health on a Mother & Baby Substance Exposure (MBSE) Initiative Learning Collaborative. • The Perinatal Health Program is partnering with CPS to identify pregnant moms with substance use disorder who currently do not have other children. These moms will be eligible to receive home visitation services from the Public Health Nurses. • There was a recent NFP graduation and Amber Hill attended and spoke. Amber also attended the education day at the Capital to educate legislators on the benefits of NFP. • Check out the documentary FOSTER which explores the world of foster care through compelling stories from the Los Angeles County Department of Children and Family Services, the largest county child welfare agency in the country. https://www.hbo.com/documentaries/foster

CCS Presentation	<p>Presented by Inez Leonard</p> <ul style="list-style-type: none">• CCS is a statewide program that can coordinate and pay for medical care, medical equipment, and rehabilitation for children and young adults who meet the criteria of:<ul style="list-style-type: none">○ Age 0-21○ Resident of county for which they are applying for services○ Financially eligible○ Medically eligible• Currently have a caseload of 7,429 children/young adults in Sacramento County• The full power point was e-mailed out
MCAH Needs Assessment Planning	<p>Presented by Stacey Kennedy</p> <ul style="list-style-type: none">• The needs assessment must be completed before the 5-year plan can be developed.• At the March meeting priority areas were identified they included:<ul style="list-style-type: none">○ Maternal Mental Health○ Maternal Substance Use/Access to Treatment○ SDOH/Health Equity in MCAH○ Preterm Birth○ Infant Mortality○ STD's• We need the MCAH Advisory Board to help us prioritize opportunities for solution strategies to create an action plan. What actions can we take that will make a difference in the community? Rank top three strategies where we may be able to have the greatest impact.• 15 ranking surveys were collected

Perinatal Equity Update	<p>Presented by Stacey Kennedy:</p> <ul style="list-style-type: none"> • The project has conducted multiple stakeholder listening sessions to understand what moms, fathers, community, social support programs and others believe are the causes of Infant Mortality and what can be done to drive change • Currently contracting with UC Davis and Mercy San Juan to conduct chart reviews for 2017-2018 AA preterm births • Contracting with First 5 Sacramento to host the Advisory Group. The group has met twice to work on SWOT analysis and discuss interventions • Working with RSE to create a media campaign to raise awareness in the community

Board Member Updates/Announcements	<p>Presented by Jackie Washington-Ansley</p> <ul style="list-style-type: none"> • There was a great turnout at the last CPSP round table where Dr. Law presented on the effects of methamphetamines during pregnancy. It was suggested that providers need additional education on how to work with babies who have been exposed to meth. • The next Round Table will be on the topic of Heroin during pregnancy. • UC Davis is now the newest CPSP provider, making a total of 14 providers.
